Deadline: December 1, 2018

### **Topic: Legal Aspects of Sport and Recreation facing Global Sport Organizations**

The Sport and Recreation Law Association grants the Undergraduate Student Research Poster Competition to an undergraduate student or a team of two students submitting the most outstanding research-based poster according to the criteria and identified topic. The winner(s) will receive a \$250 cash award and recognition at SRLA Awards Banquet.

### **Application Criteria:**

1. Students must be undergraduates at the time of the submission.
2. Students may work either individually or in a two-person team.
3. Students must have a research advisor on the project. The research advisor may not participate in actual construction of the poster contents but may provide general guidance. The poster and associated research must be the sole work of the student applicants. The research advisor must email the poster, in the template provided (Microsoft PowerPoint), to Alicia.Jessop@pepperdine.edu before 11:59 PM on December 1, 2018.
4. In the email message accompanying the attached poster, the advisor should include (a) the names of student(s), (b) email addresses of authors and advisor, and a telephone number for the advisor. An email will be sent to the advisor to confirm that the poster has been received. Late submissions will not be considered.
5. Either the student applicant(s) and/or faculty advisor must be a current member of SRLA at the time of submission.
6. The poster content must conform to APA or Blue Book style (follow current editions).
7. Students must use the provided template for the poster, but content is up to the students.
8. At least one student from the team (or the individual in the case of an individual submission) must attend the SRLA Conference and both present and explain the poster to the judges.
9. A maximum of three (3) student posters may be submitted from one academic institution.

### **Criteria for Selection:**

1. Adherence to all of the Application Criteria identified above.
2. Quality, depth, and thoroughness of research related to the legal topic provided.
3. Appropriateness of resources, especially the use of primary resources and journal articles.
4. Quality of writing and editing, and correct grammar and citation style.
5. Organization and logic of thoughts that lead to substantiated conclusions.
6. Quality of visual style of the poster.

This Award is not automatic; submissions must be of adequate quality, as determined by the Honors & Awards Committee in order to be allowed to be presented at the conference. Posters will be displayed concurrently with the Poster Session at the SRLA Conference, with the winning poster chosen by a panel of judges at the conference.
